Dear Contractor / Consultant / Supplier:

Port Tampa Bay (PTB) welcomes your interest in the Small Business Enterprise (SBE) program. PTB's Board of Commissioners adopted a policy to enhance contracting opportunities for SBE's in construction, architecture, engineering, as well as goods and services contracts. The policy encourages including registered SBE firms to the greatest extent possible on all projects. PTB has a nine (9%) percent SBE participation goal for each contract.

PTB invites you to review the eligibly requirements listed below and, if applicable, complete and submit the attached Vendor Registration Form. The SBE Policy, as well as other forms and reports, can be downloaded from PTB's website (<u>www.porttb.com/procurement</u>).

SBE eligibility requirements are listed below:

- Company is independently owned and operated, in business at least six (6) months, and have gross annual sales averaged over the previous three (3) year period of \$3,000,000 or less for goods and services or \$5,000,000 or less for construction services; and
- Maintain an office within the seven (7) county area that includes: Hernando, Hillsborough, Manatee, Pasco, Pinellas, Polk and Sarasota counties.

If the business meets the eligibility requirements, please return the completed registration form along with the documents listed below via email to <u>dcasey@tampaport.com</u>.

- Current Business Tax Receipt;
- First page of the entity's 1120S Tax Forms for the past three (3) years or current SBE Certificate from the City of Tampa or Hillsborough County;
- Proof of registration with the State of Florida (<u>https://dos.myflorida.com/sunbiz/</u>) to do business within the State;
- Current Certificate of Insurance showing coverages for Workers' Compensation & Employers' Liability, Commercial General Liability and Business Automobile Liability.

If the application is approved, you will receive an email verifying registration and an SBE Certificate along with information regarding Demandstar. PTB issues procurements through Demandstar's eProcurement distribution system (<u>www.demandstar.com</u>) which ensures registered contractors, consultants and suppliers receive automatic notification of all procurement documents, including addenda, letters of clarification and contract award notices. Demandstar will also notify you of bidding opportunities with PTB.

Your firm's name will be included in the SBE vendor directory that is available to all prospective bidders through PTB's website.
