PORT TAMPA BAY STANDARD WORK PERMIT APPLICATION #17-024 AND SOVEREIGN SUBMERGED LANDS LEASE FOR SEA WOLF HOLDINGS, L.L.C.

Sea Wolf Holdings, L.L.C. (a/k/a Interbay Marina) has applied for a Standard Work Permit and Submerged Lands Lease with Port Tampa Bay for the reconstruction of its existing multi-slip docking facility located on the Alafia River at 6210 Ohio Avenue, Gibsonton, Florida. The project would include (i) demolition of existing docks B, C, D, and E (see attached exhibit) and (ii) in-kind replacement construction of a sixty-two (62) slip docking facility with nine (9) temporary/transient slips that consists of proposed Fixed Docks A and C and Floating Docks B, D, and E (see attached exhibit). The Submerged Lands Lease would be approximately 106,360 square feet (2.44 acres) constructed on sovereign submerged lands owned by Port Tampa Bay.

Premises: Approximately 106,360 square feet (2.44 acres) of submerged lands.

based upon the Submerged Lands Rate of \$0.174244 per square feet. All future Rent will be calculated in accordance with Port Tampa Bay's

Submerged Lands Management Rules.

Other: Sea Wolf Holdings, LLC shall be responsible for all improvements to the

Premises, all real estate taxes, utility services, insurance, and maintenance of the Premises. In addition, Sea Wolf Holdings, LLC shall comply with all environmental laws and regulations, and all other applicable laws and

regulations.
