SUBMERGED LANDS LEASE WITH ZF DEVELOPMENT II, LLC

ZF Development II, LLC, managing member of Seazen GP, LLC, applied for a Standard Work Permit and Submerged Lands Lease with Port Tampa Bay for the construction of a multi-residential dock at 7616 W. Courtney Campbell Causeway, Tampa, Florida on the Hillsborough Bay. The project will include (i) the construction of a thirty-two (32) slip docking facility with a kayak launch, (ii) installation of eight (8) private aids to navigation channel markers, and (iii) two (2) "Caution Seagrass" floating buoy signs. The Submerged Lands Lease will be approximately 27,905 square feet (0.64 acre) for the multi-residential dock constructed on sovereign submerged lands owned by Port Tampa Bay.

A public hearing was held on July 14, 2017 at 10:30 a.m. to hear comments from the general public and interested parties regarding Port Tampa Bay Standard Work Permit application #16-021 and Submerged Lands Lease for ZF Development II, LLC. At the Public Hearing on July 14, 2017, some of the terms for the Submerged Lands Lease were incorrectly stated. Therefore, a new public hearing is being held and the terms are set forth below:

Premises: Approximately 27,905 square feet (0.64 acres) of submerged lands.

Term: The Lease term would be five (5) years

commencing upon the issuance of SWP #16-021. The Lease would have four (4) lease extension option terms of five (5) years each, all subject to the review and approval of Port Tampa Poy.

Rent: Annual rent for Lease Year 1 would be \$4,862.28, plus applicable

taxes, based on the Submerged Lands Rate of \$0.174244 per square feet. In addition, an one-time payment of an additional twenty-five percent (25%) of the base fee (\$1,215.57) shall be charged for the first annual fee of the Lease. All future Rent will be calculated in accordance with Port Tampa Bay's Submerged Lands

Management Rules

ZF Development II, LLC shall be responsible for all improvements to the Premises, all real estate taxes for the Premises, utility services, insurance and maintenance of the Premises and compliance with all environmental laws and regulations, and all other applicable laws and regulations.
