## TAMPA SAILING SQUADRON, INC. – SUBMERGED LANDS LEASE

Tampa Sailing Squadron, Inc. (TSS) is a non-profit sailing club located on Bal Harbour in Apollo Beach, Florida. TSS' submerged lands expired on December 31, 2017 and TSS desires a new Submerged Lands Lease for approximately 53,268 square feet of submerged lands.

**Premises:** Approximately 53,268 square feet of submerged land.

**Term:** Twenty-five (25) years which will retroactively commence on January 1,

2018.

**Rent:** Rent for Lease Year 1 is \$6,497.15 plus applicable sales tax.

Rent for Lease Year 2 is \$6,590.69 plus applicable sales tax.
