**Proposed Additional Temporary Floating Dock Design for Use in the Tampa Boat Show and Proposed Temporary Floating Dock for the IBEX 2019 Show**

**Location: 327 Franklin Street, Tampa, Florida**

National Marine Manufacturers Association (NMMA) has submitted a request to modify their existing Port Tampa Bay Permit (SWP #15-008) modifying the design of temporary floating docks for use during the annual Tampa Boat Show and the proposed construction of a temporary fourteen (14) slip floating dock for use at the 2019 IBEX Show at the Tampa Convention Center. The temporary floating docks will be located between the two (2) existing permanent docks at the Tampa Convention Center.

The proposed project has received recommendations for approval and State exemption determination from the Environmental Protection Commission (EPC) of Hillsborough County and the project has been deemed consistent with the City of Tampa Comprehensive Plan by the Hillsborough County City-County Planning Commission. In addition, a marine construction permit has been issued by the U.S. Army Corps of Engineers.
