# BACKGROUND INFORMATION FOR PUBLIC HEARING DECEMBER 8, 2022 AT 9:30 A.M.

### LAND'S END MARINA OF TAMPA, LLC – SUBMERGED LANDS LEASE

Land's End Marina of Tampa, LLC ("Land's End") owns and operates a marina located at 1220 Apollo Beach Boulevard in Apollo Beach, Florida and has a Submerged Lands Lease with the Tampa Port Authority that expired on March 31, 2022. Land's End desires to enter into a new Submerged Lands Lease for the operation of its marina for the terms set forth below:

Premises: Approximately 141,526.44 square feet of submerged land as shown on

Exhibit "A".

**Term:** Five (5) years with four (4) – five (5) year lease extension options

commencing April 1, 2022.

**Rent:** Annual Rent for Lease Year 1 (4/1/2022 to 3/31/2023) would be \$27,158.92,

plus applicable taxes based upon the Submerged Lands Management Rules rate of \$0.1919 per square foot. Land's End has paid \$17,262.34 inclusive of applicable taxes to the Port for Lease Year 1 based upon prior square footage of 84,070. The balance of \$11,025.89 plus tax will be due

upon signing of the Lease.

Per the Submerged Lands Management Rules, an additional 25% of the base fee in the amount of \$6,789.73, plus applicable tax would be due for Lease Year 1 (04/01/2022 to 03/31/2023). This is a one-time fee and is

based on the Submerged Lands Management rate of \$0.1919.

**Use:** The Premises shall be used solely for a commercial marina.

**Other:** Land's End would be responsible for the real estate taxes, improvements,

insurance, and maintenance of the Premises. Land's End would also

comply with all applicable laws and regulations.
