# HONORABLE MARCO RUBIO OFFICE LEASE AGREEMENT

Honorable Marco Rubio has served as a United States Senator representing Florida since 2011. Senator Rubio is interested in leasing office space from the Tampa Port Authority, d/b/a Port Tampa Bay, within the Joseph Garcia International Center located at 1101 Channelside Drive, Tampa, Florida 33602.

Port Tampa Bay and Senator Rubio have agreed to the following terms:

Premises: Approximately 544 square feet of office space located on the second floor of the

Joseph Garcia International Center as outlined on the "Exhibit A".

**Use:** General and executive offices only.

**Term:** Three (3) years, ten (10) months and two (2) days with no Lease Extension Options.

**Rent:** Annual Rent for the Premises will be as follows:

Base Rent: \$1,360.00 monthly or \$16,320.00 annually

Amortized Improvements: \$609.03 monthly or \$7,308.36 annually

Total Rent: \$1,969.03 monthly or \$23,628.36 annually

Tenant

**Improvement**: Port Tampa Bay shall be responsible for the cost of performing the Tenant Work up

to a maximum cost of \$28,015.51. The amortized amount will be reimbursed in equal

monthly installments during the term of the lease.

Other: Honorable Marco Rubio would be responsible for telephone and data services, and

insurance requirement of Port Tampa Bay. Port Tampa Bay would provide janitorial service, electrical and water/sewer service, and maintenance of building common

areas.
