Dear Paul,

I am happy to report that Moffitt Cancer Center's community engagement center has flourished in the last year, thanks to your generosity.

We were delighted you helped us celebrate the grand opening and welcome the community to the center.

Currently, our engagement center is operating on cruise days.

Team members speak to about 10-15 guests an hour, most of whom are cruise ship passengers. Interestingly, most of the residents who come in have been patients at Moffitt or know someone who is. It adds immense value when they share their experiences with others around them. In one instance a resident was talking about their patient experience at Moffitt and a cruise ship passenger was enthralled by the resident's story as they were not aware of the impact Moffitt Cancer Center had on its patients and community. It is these interactions that keep Moffitt top of mind and leave a lasting



impression on the guests long after they have left our premises. I am including some photos of our guests, volunteers and employees, as well as photos from the opening event. (Note with the opening that our Mole Patrol team screened more than 30 people that day and found 14 suspicious lesions, which is such an important step in finding cancer early.)

Moving forward, we want to reach more of our local population and plan to expand to non-cruise days. The center is staffed by Moffitt volunteers and team members from varying departments. The plans are to have full time employees at the site in the future.

As we seek to increase awareness of Moffitt Cancer Center and engagement, we have been using marketing collateral to inform guests about recommended screenings. QR codes link automatically to our website to schedule an appointment. We also provide postcards with contact information to the Foundation, Volunteer Services and New Patient Appointments. Currently, a lung cancer awareness event is being planned, and similar awareness events will be planned for other cancer topics as well.

We are so grateful that we have had the chance to educate our community this year and are working with our leadership to see what other initiatives we want to implement at the center.

We would like to express our deepest thanks for your support of Moffitt Cancer Center and look forward to continuing our goal of increasing education and awareness of cancer and cancer prevention.
